2010 ivball Beach Club - Season Information and Cancellation Policy

It is understood that beach volleyball is an outdoor activity subject to weather and related environmental conditions. Any ivball Beach Club ("ivbbc") session will be cancelled if ivball deems the environmental conditions to be unsafe or not conducive to proper instruction or play. Cancellation may occur the day of the session. Although ivbbc will post warnings and cancellation notices as soon as possible, members are required to be aware of the weather conditions and should contact ivbbc via phone the day of a session, if the member is uncertain of the session's status. Cancelled sessions will be rescheduled on the nearest appropriate weekend date.

Furthermore, I have read the accompanying Participant Code of Conduct as enforced by USA Volleyball and will abide by the terms and conditions within. Failure to abide by the Participant Code of Conduct may result in the revocation of ivbbc membership and dismissal from the sessions. Participant will be refunded the balance of her/his sessions remaining at \$12.00 per session and may be disallowed from future ivbbc activities at ivbbc's discretion.

I, the participant, affirm that I am eighteen (18) years of age or older, have read this document and the aforementioned *2009 Beach Club Season Information and Cancellation Policy*, and I understand its contents. I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns: a) I waive, release and discharge from any and all claims or liabilities for death or personal injury or damages of any kind, except that which is a result of gross negligence and/or wanton misconduct of persons or entities listed below, which arise out of or are related to my participation in, or my traveling to and from the volleyball event, the following persons or entities: ivball Beach Club, ivbbc, ivball, Mason Robert Inc., City of Oceanside, county of San Diego, Southern California Volleyball Association, USA Volleyball; the club director, coaches, administrators, sponsors; and the officers, directors, employees, representatives, and agents of any of the above; b) I agree not to sue any of the persons or entities mentioned above for any of the claims or liabilities that have waived, released or discharged herein; c) I indemnify and hold harmless the persons or entities mentioned above from any claims made or liabilities assessed against them as a result of my actions.

I hereby grant to ivball Beach Club and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of me, or in which I may be included, without alteration for editorial trade, advertising or similar purpose for the promotion of ivball and ivball Beach Club and in any manner and medium; I hereby release photographer and his legal representatives and assigns from all claims and liability relating to said photographs.
